#### **Best practices on Country of origin information exchanged in Bucharest**

The Expert Workshop dedicated to the country of origin information (COI) in refugee status determination (RSD) process, organised within the framework of the Eastern Partnership Panel on Migration and Asylum, was held in Bucharest, Romania. Participants from Armenia, Azerbaijan, Belarus, Georgia and Moldova and 9 EU Member States, the European Asylum Support Office, the European Court of Human Rights, the Dutch Council for Refugees as well as the United Nations High Commissioner on Refugees, the International Organization for Migration and the International Centre for Migration Policy Development attended the meeting. The workshop was co-organized by Romania, Armenia and the European Commission with the thematic focus on COI in RSD process in the EU MS and EaP countries in order to look at the sources of COI and to identify gaps and best practices in the area.

The Panel Meeting was dedicated to the information exchange on general developments in the area of migration and asylum with particular focus on circular migration in the EU and Eastern Partnership countries. The Panel's work programme for 2013 was also discussed and approved. The objective of the meeting was therefore to look at circular migration trends in the EaP region and between the EU and EaP, including in the times of economic downturn, and to identify concrete policy solutions that can be implemented both in the country of origin and country of destination. The meeting was held in Chisinau and co-organized by the Republic of Moldova, Poland and the European Commission (EC).
