EU allocates €1 Million to Armenia for dealing with return migration and reintegration problems

The European Union has allocated €1 million to Armenia for implementation of the Support for Return Migration and Reintegration program, which was presented in Yerevan. Head of EU Delegation in Armenia Traian Hristea, speaking at the presentation, said that this is part of the European Union's efforts to strengthen Armenia's ability to regulate migration flows, to develop its institutions for regulating migration flows and reintegration under the Armenia-EU joint declaration on mobile partnership.

The EU27 registered 332,000 asylum applicants in 2012, compared with 302,000 in 2011. It is estimated that around 90% were new applicants and around 10% repeat applicants, Eurostat reported.
