Foreigners to be able to get e-visa to enter Moldova

The government of Moldova approved a draft amending and completing the laws on issuing electronic entry visas for foreigners. Therefore, the Moldovan visa will be obtained more easily: applicants will no longer have to go to Moldova's diplomatic missions, but will have a possibility to apply on-line.

Moldovans granted visa-free travel across Schengen area

Moldovan citizens holding biometric passports will be able to travel to and throughout the Schengen area without a visa, following endorsement by the Council of the European Union of the respective amended regulation (No 539/2001). The new regime is expected to enter into force in early May this year and Moldova is the first Eastern Partnership country to meet all the requirements for visa-free travel laid down in the Visa Liberalisation Action Plan.

EU – Azerbaijan: 2013 a decisive year in relations, but little progress on human rights

2013 was a decisive year in EU-Azerbaijani bilateral relations, according to a progress report released by the European Commission as part of the 2014 ENP package. Azerbaijan's participation in the Eastern Partnership Summit in Vilnius, which coincided with the signing of the Visa Facilitation Agreement and the Mobility Partnership, underlined the potential to further develop EU-Azerbaijani relations.

Armenia: progress report says EU committed to cooperation despite failure to initial Association Agreement

Last year saw intensive political dialogue between the EU and the Armenian Government, according to the European Commission's ENP progress report on Armenia. Negotiations on an Association Agreement, including a Deep and Comprehensive Free Trade Area, were completed in July 2013, but they could not proceed with its initialing, following Armenia's decision to apply for membership in the Customs Union with Russia, Belarus and Kazakhstan. "Armenia and the EU remained nevertheless committed to further cooperation as they jointly stated in the margins of the Vilnius Summit," the report says.

The assessment underlines support to civil society and the population at large but expresses serious concern at the human rights situation in Belarus.

Political dialogue between the EU and the Georgian Government was intensive in 2013, according to a progress report released by the European Commission as part of the 2014 ENP package. The year saw the EU and Georgia complete negotiation of an Association Agreement, including Deep and Comprehensive Free Trade Area, in July, and the Association Agreement was initialed in November at the Eastern Partnership Summit in Vilnius.

Moldova: EU notes significant efforts and progress leading to initialing of Association Agreement

Despite the political crisis that hit Moldova in the first half of last year, the election of a new government in May 2013 allowed the EU-Moldova political dialogue to resume, leading to the initialing of the EU-Moldova Association Agreement (including DCFTA) in November, according to a progress report released by the European Commission as part of the 2014 European Neighborhood Policy package.

Ukraine: ENP progress report highlights dramatic chain of events

The European Commission's 2013 progress report on Ukraine highlights the dramatic chain of events sparked by the decision in November to suspend preparations for signing the Association Agreement, which led to massive protests in favor of closer ties with the EU, culminating in the dismissal of President Yanukovych and the appointment of a new government. The report says that in 2013 Ukraine partly addressed some of the recommendations of the last progress report, in particular those relating to electoral law and practice and the judiciary, but media freedom worsened and the perception of corruption remained high. Looking ahead to the sustained implementation of the Association Agenda in 2014, the report makes a number of recommendations including investigation





into acts of violence that took place during the recent protests, further electoral, judicial and police reforms, and stepping up the fight against corruption.
