### **Ukraine, Syria, Iraq and Iran citizens apply for asylum in Armenia**

During January–September 2015, 237 foreign citizens have applied for asylum to the State Migration Service of Armenia’s Ministry of Territorial Administration and Emergency Situations. The applications on granting asylum were submitted by 78 citizens of Ukraine, 68 citizens of Syria, 47 citizens of Iran and 44 citizens of Iraq. Refugee status was least of all granted to Iran citizens – the application of only 2 out of 47 applicants were satisfied.

### **Armenia to develop migration policy with EU aid**

Armenia is in the initial stage of negotiations for a new agreement on EU technical assistance to foster state migration policy, Deputy Head of Cooperation Section at the EU Delegation to Armenia Jose Navarro informed. The agreement is likely to be signed with the International Center for Migration Policy Development, which currently unites 15 member states in Europe. EU assistance will be split between migration and border management.

### **Azerbaijan tightens mechanism of labour migrants recruitment**

### **Visas for foreigners traveling to Azerbaijan to be issued in 3-5 days**

The issue of reducing the time of issuing visas to foreigners traveling to Azerbaijan is on the agenda, the country's Minister of Culture and Tourism Abulfas Garayev told reporters. He said that it is planned to reduce this time from 10 days to 3-5 days. Today, over 60 firms are engaged in issuing visas in Azerbaijan, the minister said, adding that over 10,000 online tourist visas were issued in 2015 alone.

## **The number of asylum applications received by Belarus is growing**

The total of 758 foreign nationals and stateless persons applied for international protection in Belarus as of 20 August 2015, Deputy Head of the Citizenship and Migration Department of the Interior Ministry of Belarus Alexander Tatura told journalists during a roundtable at the Council of the Republic on 21 August. "I would like to note that we received around 485 applications over the same period last year. The number has significantly increased due to the events happening in our neighboring states," Alexander Tatura said.

The European Commission has issued a fourth tranche of EUR 8.55 million under the program of support to the sectoral border management policy in Ukraine, the EU Delegation to Ukraine has reported. ### **Over 210,000 first time asylum seekers in the EU in the second quarter of 2015**

During the second quarter of 2015 (from April to June 2015), 213,200 first time asylum seekers applied for protection in the European Union (EU), up by 15% compared with the first quarter of 2015 and by 85% compared with the second quarter of 2014.

## **EUR 2.4 billion to fund Asylum, Migration, Integration and Security**

Over the past weeks the European Commission approved 23 new multiannual national programmes, seven under the Asylum, Migration and Integration Fund (AMIF) and 16 under the Internal Security Fund (ISF). The total funding for the agreed programmes is approximately EUR 2.4 billion. 22 national programmes were approved by the Commission earlier this year and the remaining 13 national programmes will be approved later in 2015.

## **Commission and OECD joint report: Indicators of integration of migrants**

On 2 July 2015, the European Commission (DG Migration and Home Affairs) and the OECD (International Migration Division) released "Indicators of Immigrant Integration – Settling In 2015".
