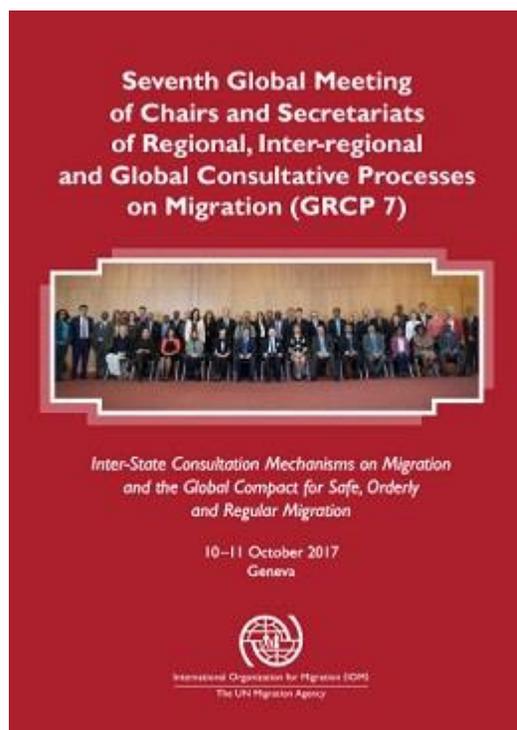

## IOM published Summary Report on the Seventh Global Meeting of RCPs on migration

IOM, the UN Migration Agency, hosted the Seventh Global Meeting of Chairs and Secretariats of Regional, Interregional and Global Consultative Processes on Migration (GRCP 7) in Geneva back in October 2017. The recently published Summary Report illustrates the role of Inter-State Consultation Mechanisms (ISCMs) in the implementation of the Global Compact for Safe, Orderly and Regular Migration and highlights the main inputs and recommendations to the Global Compact from ISCMs and their main regional partners, the regional economic organizations and UN regional commissions.

## German Government approves new refugee family reunification law

The German Government has approved legislation allowing refugees with so-called "subsidiary" status to bring their direct relatives to Germany. German Chancellor Angela Merkel's Cabinet on 9 May voted to resettle an additional 1,000 migrants per month, provided they are the direct relatives of refugees already living in Germany.

## ASAN Visa System to start granting e-visas to the nationals of 15 additional countries

According to the Chairman of the State Agency for Public Service and Social Innovations under the President of the Republic of Azerbaijan, about 420,000 foreigners have already been granted an electronic visa through the ASAN Visa System. Starting from 15 May, citizens of 15 more countries will be granted electronic visas directly at airports of Azerbaijan.

## Belarus selects supplier of hardware and software to produce biometric documents

The enterprise Cryptotech of the Mint Department of the Belarusian Finance Ministry signed a contract with the consortium of Emperor Technology (China) and X Infotech (Latvia) on purchasing equipment and software for producing biometric documents in Belarus. Identification cards will be introduced in Belarus as a personal identification document for domestic purposes. Biometric passports will be used for foreign travels.

## Georgian Government prepares legislative amendments to address irregular migration

## The Government of Ukraine introduces smart ID residence permits

Starting from 1 June 2018, permanent residence permits will be issued to foreigners and stateless persons in the form of contactless smart ID cards. The Government also approved the sample and technical description of the form for the permanent residence permits and the procedures for processing, issuing, replacing, withdrawing, invalidating, and annulling them.
